**Police protection** *contract* **with Otter Lake and Columbiaville** The Board discussed whether or not we should still request money from the Villages of Columbiaville and Otter Lake now that the police protection assessment is in place. It was decided it would not be necessary to seek money from them unless they requested special services that go beyond the scope of the contracted services

**Moore-Schlosser Drainage Dispute** Mr. and Mrs. Moore, 5056 North Lake Road were present to present pictures and discuss flooding problems on their property that they contend are caused by their neighbor's

alteration of the natural flow of water which is now being diverted onto the Moore's property. The Moore's feel that provisions of the zoning ordinance are being violated and ask the township to enforce them.

# **NEW BUSINESS**

**Fire protection amendment** Moorhouse presented the Board with some proposed amendments to the fire protection ordinance. We will begin discussions on these and solicit comments from the Fire Authority Board, as well as the Fire Chiefs.
