All costs associated with snowplowing, grading, improving and otherwise maintaining the easement will be the responsibility of Benny Schmidt & William Schmidt.

Both David Jenkins and Bennie Schmidt were present at the meeting.

David Jenkins Mr. Jenkins has no problem with the special assessment as long as the contractor doing the work is properly insured for liability.

Bennie Schmidt Mr. Schmidt does not feel he should have to hire a contractor to maintain the easement, as he feels it is the township's responsibility to do so.
