# **UNFINISHED BUSINESS**

## Update on Zoning issues

**Oliver** The machinery that was moved onto the property for a supposed auction on November 11<sup>th</sup> is still there. The auction was not held. This issue will be turned over to our attorney for further action.

**Johns** Mike Alexander and Moorhouse paid the annual visit to the Johns property to see if all the vehicles and machinery gathered on the property are operable and road worthy. Three vehicles did not start. We will ask our attorney how we should move forward

**Montney** Work on the house has been conducted without permits. The Building Inspector has tagged the house for expired permits.

**Church** Owners of the property called. Mr. Church had no authority to renovate the building and he does not own the property on which he started building.

**Rick Rhein partnership** Rick Rhien Disposal has agreed to pick up discarded tires and other debris at the township's request. We will let him know when we see or hear of items that need to be picked up from the roadside and ditches. The company will invoice us for the work accordingly.

**Deline legal description issue** The title search that was conducted by Cislo Title did not produce the information that was needed to make the change in assessing. Mrs. Deline will have to come before the Zoning Board of Appeals and ask for a variance so that this matter can be cleared up.

#### **NEW BUSINESS**

**Deputy Treasurer salary** Motion was made by Chaffer, supported by Webber to increase the Deputy Treasurer's salary to \$11.00 per hour. Roll call vote was taken. AYES Chaffer, Webber, Johnson, Glesenkamp, Moorhouse. NAYS None. Motion carried.

**Parkland Acquisition** The Board discussed the manner in which it feels is the most advantageous way to handle the purchase for the park property. It was decided that the township could pay for the land out of its capital improvement fund and then replenish the funds once we receive reimbursement from the DNR.
