PUBLIC COMMENT Deputy Lutz, LC Sheriff Department, attended in absence of Deputy Dan Hinsberger. If no progress is made in the two week dateline, Marathon Township will contract to have the property cleaned up at the expense of the Jones family. Many members of the Jones family attended the meeting. Much discussion ensued. Supervisor Moorhouse, asked Deputy Lutz, to escort the involved parties in the Jones case out of the meeting hall due to disruptive behavior. Moorhouse declared the meeting in recess at 7:30pm to bring order back into the meeting hall. At 7:35pm the township board meeting reconvened.

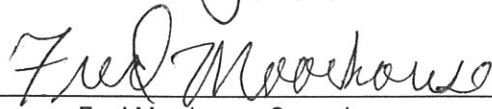
