Resignation acceptance of Tom Valentine Moorhouse made a motion, supported by Johnson to accept the resignation of Tom Valentine, but not for the reasons stated.

Approval to hire Nate Hager as new Assessor Glesenkamp made a motion, supported by Hollis to hire Nathan Hager as Township Assessor, effective 6/1/2018. His salary will be \$33,000.00. All AYES. Motion carried.

NEW BUSINESS

Sexton contract for 2018 Hollis made a motion, supported by Fuller to approve another one-year contract with Wayne Nelson as Cemetery Sexton effective 7/1/2018. Salary will be \$5100.00 for the year. All AYES. Motion carried.

Mowing Contract for park & Hollenbeck Rd property Glesenkamp made a motion, supported by Hollis to approve a contract with Wayne Nelson to perform the mowing for the Township park at \$105.00 per cutting and \$55.00 per cutting for the township-owned property on Marathon Road. Solar energy ordinance Supervisor Moorhouse will ask attorney Gildner to give us advice on creating a solar energy ordinance.

Wedding barn ordinance Supervisor Moorhouse will ask Attorney Gildner if he has ever worked on this type of ordinance.

Policy for Mike Alexander's mileage reimbursement Discussion took place on the zoning enforcement officer's mileage reimbursement as to whether he should be able to charge the township for mileage reimbursement starting at his home. It was decided that since he does not come into the office to start his work day, he can charge the mileage he drives for his job starting from home.
