PUBLIC COMMENT: Bill Bushaw spoke regarding the Southern Links Trailway Interlocal agreement and Dyle Henning gave us Lapeer County updates. Hollis made a motion, supported by Glesenkamp, to accept the changes to the SLT Interlocal Agreement for the citizen at large to be one who the board selects that doesn't have to reside in the Municipality. NEW BUSINESS

Marathon Area Fire Authority contract: Hollis gave the Township Board a copy to review and make changes as necessary.

Lawn Contracts: Moorhouse made a motion, supported by Glesenkamp, to approve the raise per cut for Marathon Township Park from \$105.00 to \$125.00 and Hemingway Lake Dam from \$27.00 to \$30.00. Roll call vote was taken. **AYES:** Coultas, Hollis, Glesenkamp, Sickner, Moorhouse. **NAYS:** None. **Motion carried.**

Shed at Marathon Township Park: Moorhouse made a motion, supported by Hollis, to purchase the shed from Michigan Storage for \$4,500.20 to place at the Marathon Township Park for the bladder tank and other essentials. Roll call vote was taken. **AYES:** Hollis, Glesenkamp, Sickner, Moorhouse, Coultas. **NAYS:** None. **Motion carried.**

Concrete for shed at Marathon Township Park: Hollis made a motion, supported by Moorhouse, to have LJ Construction do the concrete pad for the shed to sit on while they are out there this spring finishing up the contract at the park, cost would be approximately \$2,100.00. AYES: Glesenkamp, Sickner, Moorhouse, Coultas, Hollis. NAYS: None. Motion carried.

Lapeer County Road Commission Millage: Tabled until the board has a chance to read it.

Spring cleanup pay: Hollis made a motion, supported by Moorhouse, to raise up the spring cleanup pay for the people doing the tires and emptying all the trash to \$100 per person. **ALL AYES. NAYS:** None. **Motion carried.**

Sirens: Are priced about \$12,000 per siren and would be able to use the ARPA money. Marathon Area Fire Authority will possibly look at quotes and locations for the sirens and come back to the township board with recommendations.
