Vliet property, 6694 North Lake road The Vliet house was heavily damaged in a fire. The insurance company has brought in a single wide trailer for the family to live in while the house is rebuilt. They did not apply for a temporary occupancy permit nor any building permits for rebuilding the structure. The Board agreed we should turn this over to the Building Inspector to give us a report on this case.
