they want to build. The township has an ordinance that is for 200-amp service only. We are waiting for them to hand in all of the paperwork for the plans and zoning on the property.

Facemask order discussion with Attorney Mike Gildner: We need to be in compliance with the Gatherings and Face Mask Order from the MDHHS.

Police assessment discussion with Attorney Mike Gildner: We plan to set up a public hearing for April 21, 2021 @ 6:00pm for the first part of the assessment. We need to establish the district, cost estimate and to listen to objections.

North Lake assessment for weed control discussion with Attorney Mike Gildner: Moorhouse has contacted the clerk at Watertown Township multiple times to get information on the weed control to no avail. The Township Board is waiting for all of the information prior to putting it on the agenda.

B&B Lawn & Landscape contract: B&B is stopping cutting grass starting in 2021. Hollis is going to get in touch with Wayne Nelson, who cuts other grass for Marathon Township, and see if he would be interested in cutting the grass at the Township Hall.
