NEW BUSINESS

Lapeer County Sheriff Contract for 2020 The Board discussed some concerns it has with the present contractual agreement. There is a good chance that the County will decrease the amount it is willing to match for the 2020 contract

Computer support Johnson shared a letter she had received from Thumb Communications about serving our computer support needs. With Mike Diericks leaving LJ Electric, it may be a good time to change providers. Johnson will check references with Lapeer Township and Deerfield Township, as they currently use Thumb Communication's services.

Electrical Inspector The Building Department is experiencing problems with the electrical inspector again. He does not respond in a timely manner to get his inspection schedule. He often leaves the property owners in limbo and waiting for their inspections. Hollis said she would contact Opperman Electric to see if they might have anyone who could perform inspections for the township.

Road Commission project at Willits and Burnside Roads. Joe Haack, Road Commission Foreman has a road project in mind for Willits and Burnside Roads to which Deerfield Township will share the costs. Johnson will contact Joe and ask him to attend a meeting to give us more information on the project and update the Board on other issues.
