# Marathon Township Community Park Rules

## **IT IS PROHIBITED TO:**

1. Intentionally damage, deface, or destroy any tables, drinking fountains, recreational equipment, or other equipment, structures or buildings of the Townships.
2. Pick or mutilate any flower (wild or domestic), or intentionally disturb trees, shrubs, or other plant material.
3. Possess, transport or consume any alcoholic beverages.
4. Advertise by any means or method without the consent of the Township.
5. Knowingly permit a dog, cat, or any small domestic animal to enter or remain in the park unless said animal is properly restrained by a 6' leash.
6. Throw, discard, or leave any papers, litter, garbage, or rubbish unless the same is deposited in containers furnished by the Township for this purpose.
7. Discharge firearms.
8. Plant trees, flowers, weeds or vegetables without the consent of the Township.
9. Operate any motor vehicles, motorcycles of any size, go-carts, snowmobiles, etc., unless the person is an officer, employee, agent, or person under contract from the Township to enter or work upon the Park.
10. Remain in, use or occupy of any portion of any park between the hours of 10:00 pm and 6:00 am.
11. Start a fire.
12. Possess, or ignite any fireworks.
13. Masking tape must be used to hang any decorations and must be removed at the end of your event. **No push pins or nails allowed. (NO holes in the pavilion or poles at all)**

The person signing this registration on behalf of the above group assumes personal liability for all damage to park property and takes responsibility for the group's ability to follow all Park Rules and Regulations.
