ELECTRICAL PERMIT INFORMATION

Construction or work for which this permit is required shall be subject to Inspection by the Code of Sixth construction or work shall remain accessible and exposed for the purpose of inspection until approved.

A final inspection is required on this permitprior to any equipment being placed into operation, and ishall be the Contractor/Owner's responsibility to coordinate entry for that purpose.

The current rate for reinspection is \$80.00.

Permits are valid for (180) days from the date of issuance, provided that an inspection takes place within that timeframe, after (180) days, a renewal is required for each additional (180) days, at a rate of \$40.00.

Ground fault interrupters are required on all residential outside receptacles, including garages, accessory buildings, and all residential bathroom and kitchen receptacles.

Approved "fire stopping" materials shall be installed where holes are drilled through any plate or stud, and any cold air return.

Service and rough inspections can be covered under one (1) inspection on a new dwelling if both are ready. There will be an additional charge if not inspected at the same time. Additions or remodeling require two (2) inspections (rough & final).

The Electrical Official will be responsible for contacting Detroit Edison to release the service hook-up and initiate power.

All fixtures must be hung, and lamps and plate covers installed, for final.

Pre-manufactured home installations require four (4) wire installation, from disconnect to service panel.

Interconnected 110V w/battery back-up smoke detectors shall be installed on each level of the dwelling, in the vicinity of each bedroom, and in each bedroom.

Dwellings not conforming to current smoke detector requirements shall "upgrade" when altered or expanded.

Swimming pool installations require any wiring entering or exiting the ground to be in conduit, with GFI protection. A continuous grounding bond of #8 bare solid copper wire shall be installed on four (4) sides of the pool, ladder, and diving board.

Above ground: One (1) inspection.

In ground: Two (2) inspections (underground & final).

Air conditioning units require final inspection prior to being placed into operation.
